Proactiveness

Baseline

Begin by identifying key areas of risk and developing a plan for proactive steps to address them, such as training programs or regular risk assessments.

Progressing

Expand proactive measures by using data collection, analysis, and monitoring.

Mature

Incorporate predictive analytics to detect new areas of risk that equip you to implement mitigating measures.





Consistency

Baseline

Document your current investigative processes and provide basic technique training to your colleagues.

Progressing

Review existing processes to identify gaps and opportunities for improvement. Update documentation accordingly.

Mature

Continually review and refine investigative processes and develop a comprehensive framework for how investigations should be conducted across the organization.

Review your current investigative process to identify bottlenecks, assess inefficiencies and implement process improvements.

Progressing

Leverage automation tools such as case management software and workflow management systems to streamline the investigative process.

Mature

Implement a continuous improvement program to identify and address inefficiencies and areas for improvement on an ongoing basis.



Collaboration

Baseline

Begin by developing protocols between different functional groups involved in investigations.

Progressing

Establish regular meetings or working groups to facilitate collaboration and information sharing.

Mature

Develop a process that allows for realtime collaboration and information sharing between all colleagues who conduct investigations.





Documentation

Baseline

Establish a consistent process for all investigations and ensure that all necessary information is captured and recorded.

Progressing

Implement a centralized database or case management system to store and manage all investigative documentation.

Mature

Develop a comprehensive documentation system that includes standard templates, checklists, and reporting requirements, including automation, for all investigations.



Technology

Baseline

Begin by conducting a review of existing technology systems and identifying areas where new technology could be integrated.

Progressing

Implement technology solutions that streamline investigative processes and improve data analysis capabilities.

Mature

Develop a comprehensive technology strategy that fully integrates technology into all aspects of investigative processes, from case intake to reporting.



Business Impact

Baseline

Begin by establishing clear success criteria for investigative outcomes, and regularly review and assess outcomes against these criteria.

Progressing

Develop and implement metrics and reporting processes to measure the effectiveness and consistency of investigative outcomes.

Mature

Conduct regular reviews of investigative outcomes to identify areas for improvement or optimization and incorporate into your program.
